



Policy for Stock Vehicles/Trailers Parked on the Fairgrounds

Due to limited space on the grounds please adhere to the following Stock Vehicle/Trailer Policies.

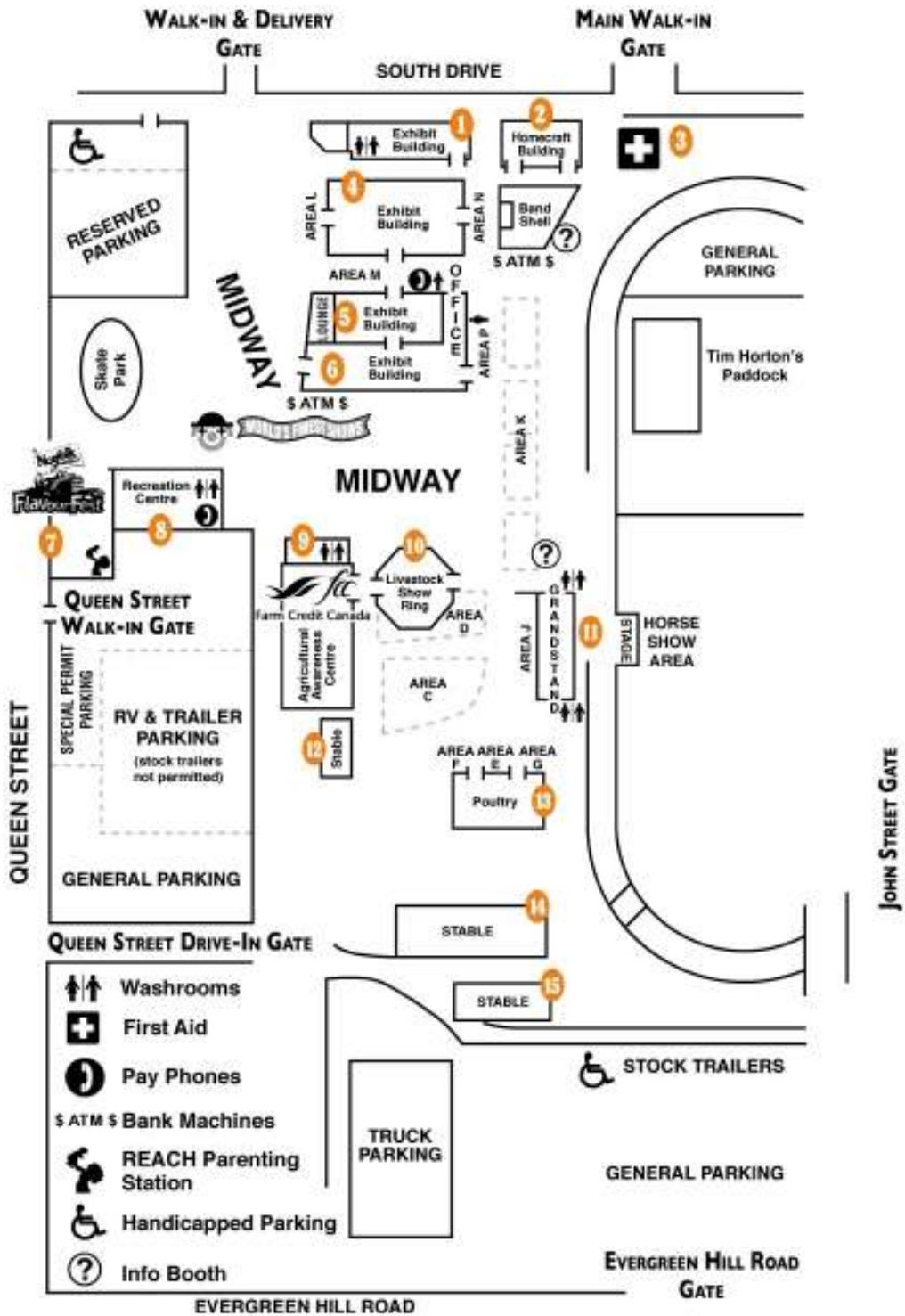
Filling in the Stock Vehicle/Trailer Registration form does not guarantee space, as space will only be provided for your stock vehicle/trailer if room is available.

1. All Exhibitors with stock vehicles/trailers on the Fairgrounds must register at the Fair Office. Once Registration has been received you will be notified if sufficient space to accommodate your stock vehicle/trailer is available.
2. If you brought a stock vehicle/trailer the previous year (and there are no changes in size, parking location, type of stock unit etc.) please consider your stock vehicle/trailer pre-approved. We do however request, that you register the information as outlined on the attached Registration Form.
3. All stock vehicle/trailers must park in the designed area at the South end of the track or in the General Parking areas (see map on back).
4. Stock vehicles/trailers are not permitted in RV/Trailer Parking area, on Concession Site or in Reserved Lot parking areas unless special permission has been granted and permits purchased.
5. The following fees will apply...

\$100.00	Refrigerated or non-refrigerated stock vehicles/trailers parked on the vendor's outdoor concession site
\$130.00	Refrigerated stock vehicles/trailers parked on the vendor's outdoor concession site & powered by WFS generator
\$100.00	Refrigerated stock vehicles/trailers parked in the designated stock trailer area at the South end of the track or reserved lot area
\$50.00	Non-refrigerated stock vehicles/trailers parked in designated stock trailer area at the South end of the track or General Parking area

6. If your exhibit contract/invoice does not indicate a stock vehicle/trailer fee and you have registered and the parking location for the stock vehicle/trailer on the grounds has been approved, please revise your exhibit contract to include the appropriate fees as indicated above.
7. Any stock vehicle/trailer, which cannot be properly identified, or is not registered at the Fair Office, will be removed off the property at the owners expense.
